Incorporated in May 2024, Green Marine International is the governance structure overseeing the environmental certification programs in North America, Europe and, as of 2025, Australia and the Caribbean.

Founded in 2007, the <u>Green Marine</u> program in North America is the result of a voluntary effort by the shipping industry to go beyond regulations. More than 185 ship owners, ports, terminals, and shippards throughout Canada, the United States and most recently Mexico are participating in the program.

Launched in 2020, <u>Green Marine Europe</u> currently has 26 ship owners, representing a large and diverse maritime fleet of more than 500 vessels, and three major shipyards in the program.
